The 107-year-old Zhejiang Road Bridge, the second oldest bridge on the city's Suzhou Creek, which has been restored to its original look after a nine-month long renovation, will open for traffic at 8pm on December 28, the Shanghai Road Administration Bureau said.



Hongmei Road S. tunnel, the 13th tunnel under the Huangpu River linking Puxi and Pudong, is scheduled to open on December 30. The opening of the tunnel, which connects Minhang and Fengxian districts, will be especially welcomed by people living in the southern rural districts, who will now have easier access to the city center.

Work on the Chenta Bridge in Songjiang District, the 12th bridge over the Huangpu River, is scheduled to open for traffic at 3pm on December 30.

## Reforms in FTZ set to move quicker

December 30 2015

Shanghai will free up overseas investment for individuals and connect the Shanghai's and London's stock exchanges to accelerate financial reforms in the free trade zone, officials said on December 29.

The Shanghai headquarters of the People's Bank of China said it will allow individuals to invest overseas directly while also letting banks, brokerages and insurance companies innovate their operations through free trade accounts, and relaxing foreign exchange controls with a negative list.

Details of the widely anticipated Qualified Domestic Individual Investor program, which will allow persons to invest in capital, real estate and industrial sectors, are being drafted. But no timeframe has been set for their release.

Over 40,000 free trade accounts were set up in the FTZ at the end of November and they transacted RMB 1.83 trillion in the first 11 months, official data released on December 29 showed. Cross-border transactions totaled RMB 1.05 trillion in the first 11 months in the FTZ, taking up 43 percent of the city's total.

2015年12月28日

上海市路政局发布消息称，作为苏州河上历史第二悠久的钢结构老桥，107岁的浙江路桥在经历了9个月的原貌修复后，于12月28日20时正式通车运行。

连接浦西至浦东的虹梅南路隧道，是贯穿黄浦江底的第13座越江隧道，计划于12月30日开始通车运行。作为连接闵行、奉贤两区的重要越江隧道，它尤其便利了居住在城市南部郊环区域的居民，使其更方便进入市中心区。

位于松江区的辰塔大桥，是横跨黄浦江的第12座跨江大桥，预计于12月30日15时正式通车运行。

#### 自贸区改革政策将加快落地进程

2015年12月24日

官方12月29日消息称，上海将放宽个人海外投资限制，并支持上海证券交易所和伦敦证券交易所就互联互通可行性问题的研究，以促进自贸区金融改革。

中国人民银行上海总部称，未来将允许个人进行海外直接投资，以及银行、股票经纪公司和保险公司等通过其交易账户进行业务创新，并且通过放松外汇管制等一系列的促进措施。

广义预期的合格境内个人投资者计划细节仍在制定中，届时将允许个人投资资本、房地产和实业部分，但具体计划进度仍未发布。





12月29日发布的官方数据显示，截止11月底，自贸区已开设超过4万个交易账户，且前11个月已实现18,300亿元人民币交易额。而自贸区前11个月的跨境交易额也已达到了10,500亿元人民币，占上海市跨境交易额总量的43%。
